ADOPTION OF AGENDA

REPORT ON THE FREE AND REDUCED MEALS (FARM) REPORT

Rick Baldwin reviewed the Free and Reduced Meals (FARM) Report. Mr. Baldwin explained the report will help AZAC determine the socioeconomic impact a zone change would have to a school's Free and Reduced Meal program.

Jose Solorio said it is good to have parity within the schools and asked if the Free and Reduced Meals Report provided a percentage breakdown.

REPORT ON THE PERCENTAGE CHANGE

Rick Baldwin reviewed the percentage change. Mr. Baldwin explained the percentage change represents the percent of students attending a school based on the geographic boundary.

#### SCENARIOS FOR FOCUS AREA E2 FOR ELEMENTARY SCHOOLS

Focus area E2 evaluates the existing attendance boundaries of Allen, Bilbray/Scherkenbach, Bozarth, Darnell, and Thompson Elementary Schools.

Rick Baldwin presented three scenarios.

Sheri Garbiso, GIS Senior Analyst, Demographics, Zoning & GIS, reviewed new residential developments within focus area E2 that are currently building and/or selling homes and the student yield expected from new developments.

Anna Slighting said the numbers were equally distributed in scenarios one and three. Mrs. Slighting said she favors scenario one as the students who live in the neighborhood of Elkhorn Road and Dorrell Lane are able to walk to Bozarth Elementary School. She believes scenario two still leaves too many students at Bozarth Elementary School. Mrs. Slighting looks forward to public input.

Jose Solorio said he prefers scenario three as it provides the best long term distribution of students to maximize each school's capacity.

Rick Baldwin informed the commission Allen Elementary School provides some relief to this area through open enrollment.

Ray Negrete, GIS Coordinator III, Transportation Department, said a transportation cost analysis will be provided for each of the scenarios.

#### SCENARIOS FOR FOCUS AREA H1 FOR SECONDARY SCHOOLS

Focus area H1 evaluates the existing attendance boundaries of Arbor View and Shadow Ridge High Schools.

Rick Baldwin reported there is currently only one scenario being considered for focus area H1. Mr. Baldwin explained the area south of I-215 and north of Ann Road is out of feeder school alignment and a boundary adjustment is needed in order to have total feeder school alignment from Saville Middle School to Shadow Ridge High School. Mr. Baldwin also said with the Kyle Canyon Gateway residential development located in the Arbor View High School boundary, the feeder school boundary adjustment will help balance the enrollment. Mr. Baldwin said a good percentage of students within the geographic boundary of Arbor View and Shadow Ridge High Schools choose to attend other schools; with its close proximity, a large number elect to attend the Northwest CTA. Mr. Baldwin said there is a lot of future development on the west side of the Arbor View High School zone and this boundary adjustment is a good solution to the current situation as it will help to counteract some of the growth within their boundary.
