Rick Baldwin stated the purpose of these changes is to create elementary to middle school alignment. Agenda Item 3.13 will align Frank Kim Elementary School to feed 100% to Clifford J. Lawrence Junior High School; Item 3.14 will align Joseph E. Thiriot Elementary School to feed 100% to Grant Sawyer Middle School; and Item 3.15 will align Harvey N. Dondero Elementary School to feed 100% to Kenny C. Guinn Middle School. Mr. Baldwin stated these changes will be made with phasing, moving only incoming sixth grade students each year.

Rick Baldwin stated the purpose of these changes is to create elementary to middle school alignment. Mr. Baldwin stated Agenda Item 3.16 will align a small number of students who were the only ones attending a certain middle school with their cohorts; Item 3.17 will align J. M. Ullom Elementary School with C. W. Woodbury Middle School; and Item 3.18 will align John F. Mendoza Elementary School with

Duane D. Keller Middle School. Mr. Baldwin stated staff recommends postponing Item 3.19 until next year to allow corrections necessary to achieve elementary to feeder school alignment as a result of the passage of the previous elementary school Agenda Items.

PUBLIC COMMENT PERIOD

David Gomez stated he is speaking as Nevada Peace Alliance president, deputy director for Nevada of LULAC (League of [United] Latin American Citizens), former president of Wake Up, and also a member of legislation lobbying. Mr. Gomez stated he listened to, he loves Director Baldwin, he [Mr. Baldwin] does a good job, but when you say staff recommends, it was more like the commission recommends. Mr. Gomez sat up there and watched the back and forth every single day, so when you say that staff recommends I believe that commission should be inclusive in that when the commission is the one that's the advisory giving the staff the recommendation based on what they vote on, whether it's a aye or nay, so there's nothing wrong with that but he just wanted to point that out because the commission does do a awesome job at going back and forth, listening to public comment, using our own gas money, using our own time, using everything of our resources period, to make sure that we get everywhere to meet with these parents and with these families to find out exactly what it is that they're looking for and find a resolution and resolve that they're happy with and that's the most important thing; nobody give us no expedentures, we don't get

paid for this, we just get a big thank you at the end of the year with a dinner or luncheon or something. Mr. Gomez stated you know it's something when you say the commission recommended to us and we recommend based on the commission's information that we move forward with this that would be more appropriate to give them their acknowledgement than to say staff recommends because staff can't vote on anything if he can recall correctly, so thank you very much.

Albert Delgado thanked the Board of School Trustees for another great group of appointees on the AZAC commission. Mr. Delgado stated, in spite of different opinions, they come together to do their work efficiently. Mr. Delgado thanked staff for their support.
